

## THE ZUMIEZ STASH SWEEPSTAKES

### Official Rules

Dates: 3/12/2019 – 4/22/2019

**1. NO PURCHASE NECESSARY.** Sweepstakes begin at 12:01 a.m. 3/12/2019 and ends at 11:59 p.m. 4/22/2019. For purposes of these Official Rules, all times are Pacific Time (“PT”).

**2. ELIGIBILITY.** Sweepstakes are open to legal residents of the 50 United States, the District of Columbia, and Canada (excluding Quebec). If the winner is under the age of 18, the winner’s parent or legal guardian must give consent. Legal residents of Canada (excluding Quebec) who have reached the aforementioned age in their province of residence at time of entry are also eligible to enter. Void in Puerto Rico and where prohibited by law. Entrant must have internet access as of 3/12/2019 in order to enter the Sweepstakes.
