

# THE ZUMIEZ STASH SWEEPSTAKES

## Official Rules

**Dates: [3/7/2023 – 6/1/2023]**

**1. TIME PERIOD; NO PURCHASE NECESSARY; SPONSOR.** Sweepstakes begin at 12:00 a.m. [3/7/2023] and ends at 11:59 p.m. [6/1/2023]. For purposes of these Official Rules, all times are Pacific Time (“PT”). No purchase is necessary to enter and the methods to enter the Sweepstakes are set forth in Section 3 below. The sponsors of this Sweepstakes are Zumiez Inc. and [Adidas, Cons, New Balance] (“Sponsors”).

**2. ELIGIBILITY.** Sweepstakes are open to legal residents of the 50 United States, the District of Columbia, and Canada (excluding Quebec). Entrants must be over the age of 13 to participate in this Sweepstakes. If the winner is under the age of 18, the winner’s parent or legal guardian must give consent. Legal residents of Canada (excluding Quebec) who have reached the aforementioned age in their province of residence at time of entry are also eligible to enter and are also subject to additional eligibility requirements as described further in Section 7 below. Void in Puerto Rico and where prohibited by law. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter, if applicable, will be deemed to be the entrant. "Authorized account holder" of an email address is defined as the natural person who is assigned to an email address by an Internet Access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Employees, directors, officers, agents officers and consultants and members of the immediate families and persons living in their households of Sponsors, CrowdTwist and their respective advertising and promotion agencies involved with this Sweepstakes, and their respective parent companies, subsidiaries, affiliates, are not eligible to enter. The Sweepstakes shall be staged in compliance with all applicable federal, state, and local laws and are void to the extent they are not in compliance.

**3. HOW TO ENTER.** Entries may be made by either of the process described below in sub-section A or subsection B. All entries are subject to the requirements set forth in sub-section C.

A. The Zumiez Stash member may enter the Sweepstakes by going to the Zumiez Stash online or Zumiez Stash App and following the instructions to redeem the required [500] points for sweepstake entry. Registration for the Zumiez Stash is free and available by going to <http://www.zumiez.com>, [www.zumiez.ca](http://www.zumiez.ca), or by clicking on the link to the Apple or Android stores to download the free “Zumiez Stash” app (the “Mobile App”).

B. MAIL IN. An entry may also be made by mailing (1) one entry without using any Zumiez Stash points by writing their Name, Email Address, Date of Birth, Phone Number, and Mailing Address to: Zumiez Stash [‘Get Your Kicks! C. GENERAL. Entries generated by a script, macro or other automated means will be disqualified. Entrants must accurately provide all of the requested information to be eligible to win. Incomplete, unintelligible entries will be disqualified. All information provided by entrants to enter the Sweepstakes becomes the property of Sponsors and may be used in accordance with Sponsors' privacy policies. **ELIGIBLE ENTRANTS MUST SUBMIT THE REQUESTED ENTRY INFORMATION IN ACCORDANCE WITH THESE OFFICIAL RULES. NO OTHER METHOD OF SUBMISSION WILL BE ACCEPTED.** Participation in the Sweepstakes constitutes Entrant's (and, if the Entrant is under the age of majority, the Entrant's parent or guardian's) understanding of, full and unconditional agreement to, and acceptance of these Official Rules. Sponsors reserve the right to disqualify any Entrant that Sponsors determine to be in violation of any term contained in these Official Rules. Sponsors' decision not to enforce a specific provision of these Official Rules does not constitute a waiver of that provision or of the Official Rules generally.

**4. ODDS.** A purchase or payment of any kind is not necessary to enter or win and a purchase will not increase your chances of winning. Odds of winning depend on the number of eligible entries received. Void where prohibited.

**5. CHANGE OF EMAIL ADDRESS OR CELL PHONE NUMBER POLICY.** It is the sole responsibility of the entrant to notify Zumiez in writing or by email if the entrant changes (1) his/her email address or (2) his/her cell phone number. **6. PRIZES** There will be 3 winners  
- 12 pairs of shoes from your choice Adidas, New Balance or Converse

The depiction of the Prize in any advertising or promotional materials may not reflect the actual Prize delivered to the winner.

Winner is solely responsible for any and all taxes on the Prize, as well as any and all expenses relative to participation in the Sweepstakes not specified herein. No prize substitutions allowed except at sole discretion of Sponsors. Prizes are not transferable. Sponsors reserve the right to substitute Prizes with prizes of equal or greater value, if Prizes become unavailable for any reason. Any portion of the Prizes not accepted by the winner will be forfeited.

Sponsors and their respective parents, subsidiaries and affiliated companies maintain no control over the personnel, equipment, or operation of any air, water or surface carrier, ship line, bus or limousine company, transportation company, hotel, restaurant, or other person or entity furnishing service, products, or accommodations as a part of any Prize packages. Sponsors shall not be liable for any injury, damage, loss, expense, accident, delay, inconvenience, or other irregularity that may be caused or contributed to (1) by wrongful, negligent, or unauthorized act or omission on the part of any of those suppliers or any of their agents, servants, employees, or independent contractors, (2) by any defect in or failure of any vehicle, equipment, instrumentality, service, product, or accommodation that is owned, operated,

furnished, or otherwise used by any of those suppliers, (3) by the wrongful, negligent, or unauthorized act or omission on the part of any other person or entity not an employee of Sponsor or (4) by any cause, condition, or event whatsoever beyond the control of Sponsors.

**7. SELECTION OF WINNERS.** If Prize winners have not attained the age of majority in the state or province of residence, the Prize will be awarded in name of a parent or guardian. In the event the winner is a resident or citizen of Canada (a "Canadian Winner") then, the Canadian Winner must correctly answer, unaided and within a set timeframe, a mathematical skill testing question as a condition of receiving the Prize. By accepting and/or using the Prize, except where prohibited, all winners grant to Sponsors and their respective advertising, press and marketing agencies the right to use, and publish his or her proper name, likeness, voice, opinions, biographical information and state/province and announce winner's name, home city and state/province in any media to promote Sponsors and the Sweepstakes without additional compensation. If a selected winner cannot be contacted, is ineligible, fails to claim a Prize, or fails to timely return a completed and executed declaration and releases as required, the Prize may be forfeited and an alternate winner selected. In the event of a dispute regarding who submitted an online entry, the entry will be deemed submitted by the authorized account holder of the email account. Sponsors reserve the right to disqualify any person or email address that Sponsors determine to be in violation of any term contained in these Official Rules. By accepting a Prize, winners also release Sponsors and their respective directors, officers, agents, employees, officers and consultants and their marketing and promotion agencies from any and all liability, claims or actions of any kind whatsoever for injuries, damages or losses to persons and property which may be sustained in connection with the receipt, ownership or use of the Prize.

**8. CONDITIONS OF PARTICIPATION.** Sponsors are not responsible for misdirected mail, incorrect or inaccurate capture of entry information, including but not limited to malfunctions, human error, lost/delayed/garbled data or transmissions, omission, interruption, deletion, defect, failures of: any telephone or computer line or network, computer equipment, software or any combination thereof. Entry materials/data that have been tampered with or altered are void. In the event this Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, Sponsors reserve the right to cancel, terminate, or suspend the Sweepstakes and, in such event, to select a winner by random drawing from among all valid entries received up to such time of cancellation, termination or suspension. The potential winner will be notified within approximately 72 hours after drawing by email and/or phone and may be required to complete, sign and return an Affidavit of Eligibility/Release of Liability and Publicity Release (where legal). If the potential winner does not reply to such notification, the notification is undeliverable after up to three (3) attempts and/or the Affidavit and Releases are not returned as instructed within seven (7) days of their transmission, potential winner will be disqualified and an alternate winner will be selected in a random drawing. In the event that a potential winner is a minor under the age of 18 or the age of majority in the relevant state or province, his/her parent or legal guardian will be notified by email and will be required to sign and return via fax or to an address designated in said email, a Parental Permission Form (signifying permission for the minor to be declared a potential winner) as well as the Affidavit and Releases. In the event that this notification is returned as undeliverable, Zumiez will attempt to re-send up to three (3)

times. If the Parental Permission Form, the Affidavit, and Releases are not returned within seven (7) days of their transmission, or should the email after three (3) attempts be returned as undeliverable, such potential winner will be disqualified and an alternate winner will be selected. All responsibilities of a minor will be assumed by his/her parent/legal guardian.

**By entering this Sweepstakes, entrants release Sponsors, CrowdTwist, the manufacturer or donor of any Prize and their respective parent companies, subsidiaries, affiliates, directors, officers, contractors, employees and agents from any responsibility and all liability whatsoever for any injuries, losses, death or damages of any kind caused by participation in the Sweepstakes or in connection with acceptance, possession, use, or misuse of the Prize provided pursuant to the Sweepstakes.**

All entrants, as a condition of entry, agree to be bound by these Official Rules and by the decisions of Sponsors which shall be final and binding in all matters relating to this Sweepstakes.
